**10/25/09 Ward 3** At 8:08 pm dispatched to **Tulane Park Apartments** in reference to vandalism of vehicle. Complainant stated it had just happened. The trunk lid and the right front and rear doors had been keyed (scratched). Complainant has a suspect in mind.
