2/1/10 Ward 1 At 9:28 pm patrol until was in parking lot of **Drury Inn** and noticed a maroon GMC pickup with passenger window busted out. The owner had parked the vehicle at approximately 9 pm. Missing from the vehicle was a Garmin GPS and a blackberry car charger.

2/4/10 Ward 4 At 9:30 am dispatched to **6400 block of Forest Glen** in reference to burglary of vacant residence. Complainant had brought tools to the home doing repairs. They were last observed at 8 pm the previous night. The back sliding glass had been removed and left open. Complainant has a suspect in mind.

2/4/10 Ward 5 At 10:05 pm responded to **Guadalajara Grill** (7070 Highway 301) for burglary of a vehicle. While on this call another vehicle was found to have been burglarized. Both had the passenger side window busted out. Items taken included a CD player, sweater, hat and cash that was concealed in console.

2/9/10 Ward 6 At 7:20 pm walk in at headquarters stating work van parked in **5700 block of Laurie** was burglarized the night before. He did not notice until he was at work and needed his diagnostic scanner from back seat area and it was missing along with laptop. The rear door had been tampered with and these two items were missing.

2/10/10 Ward 1 Dispatched to **Outback Storage** in reference to damage of 2004 Chevrolet Avalanche. Complainant stated the catalytic converter had been removed. Noticed this at 9 am and vehicle was last observed at 3 pm the day before.

2/10/10 Ward 6 Approximately 3:45 pm dispatched to **5700 block of Jordan** in reference to a stolen 4 wheeler. Described as 2007 red Recon 250 TRX. It was stolen between the hours of 9:30 am on previous day and the time of call. Complainant stated it could have been juvenile related as they had ridden the day before and failed to put the lock back on the chain.

2/12/10 Ward 4 Approximately 12:30 pm dispatched to **3700 block of Pembroke Cove**. This is the second time this home has been broken into. The first time a window was busted and repairs were going to be made at this time when complainant found rear door kicked in. The master bedroom was ransacked and DVD's, cologne and knife was taken. The home was broken into between the hours of 2 pm the day before and the time of call.

2/12/10 Ward 4 Dispatched to **6300 block of Forest Glen** at 5:09 pm regarding burglary of a residence. Homeowner left home at 7 am and arrived at 5:07 pm and found window broken out. Missing from home included two Sony PSP gaming systems, Xbox 360, numerous games and movies as well as some cash. Neighbors on each side did not observe anything suspicious.

2/18/10 Ward 6 Dispatched to **5600 block of Winterwood** at 10:45 pm for report of stolen property. Complainant stated they last saw large heavy duty wheelbarrow and shovel at 7 pm. At 10:40 pm items were missing from carport.

2/20/10 Ward 3 At 2:15 am responded to **7000 block of Tulane** for burglary of a vehicle. A white male was observed by a resident breaking inside door window of a 2004 Ford F150. The white male appeared to be thin, about 6 ft and had on a black hoody. The vehicle owner stated nothing of any value was taken from the vehicle.

2/20/10 Ward 5 Approximately 8:17 am dispatched to **5800 block of Briarwood** for vandalism of a vehicle. The vehicle was last observed at 6 pm on previous evening. The hood was scratched and berries were thrown on the windshield.

Missing from the vehicle was a Kenwood TV/Tuner, 12" subwoofer and a Garmin GPS. Owner of vehicle has a suspect in mind.

2/24/10 Ward 1 Approximately 1:20 pm dispatched to **6400 block of Arbor Lake Drive East** in reference to burglary of a residence. Homeowner left approximately 8 am and returned just prior to calling police. The front door trim was broken and the door was open. Stolen items included an IPOD, DVD player, TV, sound system, guitar, rifle and handgun.

2/24/10 Ward 1 While on the above call noticed the house next door also had an open front door. When we entered house, noticed TV and laptop in plain view. The homeowner was notified and made scene.

2/25/10 Ward 3 Approximately 6 pm dispatched to **2600 block of Ridgewood Cove** in reference to stolen property. On 2/24/10 placed a Playstation 3 in vehicle at 1:00 am. Discovered Playstation 3 and cables missing at 3:00 pm.

A window had been broken and house was ransacked. Some of the items missing included a TV, laptop, DVD player, digital camera, loose change and medications.

2/27/10 Ward 4 At 6:55 pm dispatched to **2600 block of South Avalon** for burglary of a residence. Homeowner left at 1:00 pm and when he returned the home was severely ransacked. The resident was unable to determine at the time if anything was missing. Possible suspects are juveniles.
