Subsubsection (j) revise to read as follows: ECMS shall not be permitted in the Highway 51 and the I-55 sign overlay districts, except for digital pricing signs used to display the cost of fuel sales, provided that such digital pricing sign meets all other requirements of this article and except for billboards in the I-55 sign overlay district.

- c. Section G. Prohibited Signs, Subsection 22. revise to read as follows: Off-premise[s] signs, except in the I-55 Interchange District.
- d. Section K. Interstate 55 Interchange District.
  - Subsection (2) revise to read as follows: Notwithstanding height requirement in all commercial zones as described in this chapter, the maximum height permitted for ground signs, including billboards, in this overlay district shall be forty (40) feet.
  - Subsection (3) revise to read as follows: Notwithstanding the maximum size requirements in all commercial zones as described in this chapter, the maximum face size for ground signs, including billboards, shall be 672 square feet, with maximum dimensions of 48 feet wide and 14 feet tall.
  - iii. Add the following subsection: 4. All regular billboards must be 500 feet from each other, while digital or ECMS-type billboards must be 1,000 feet from any type of billboard.

\*\*At this time the Mayor opened the public hearing on Case No. 2079 CU – Request for conditional use for a cemetery on 1.2 acres of a larger 80 acres + - parcel located at 4600 Church Road West. Mr. Bahr presented the staff report and PowerPoint presentation on the case. The Planning Commission recommended approval of the conditional use 4-3 with conditions Mr. Maher Abuirshaid of 3418 Shiloh was present to answer any questions as was Mr. Rivadh Elkhavyat applicant and owner. Mr. Abuirshaid stated that he would abide by the recommendations being proposed currently. The city attorney directed Mr. Abuirshaid's attention to the 5 conditions listed on the screen and inquired if the conditions were acceptable. Mr. Abuirshaid stated that they were acceptable. Mr. Francis J. Miller of Horn Lake addressed the Planning Commission's recommendation relative to the mosque being built before the cemetery. Mr. Calvin Freeman of Horn Lake inquired about the presence of mausoleums and whether there would be lighting.
